Strengths

The paper concerns quite relevant theoretical matters in the institutional economics. The Coase theorem considered as an element that determines a basic understanding of the regularities in a behaviour of economic agents in the market is a clear evidence for it. The authors outline an available scientific challenge of externalities' identification, which appears in logic verification of the Coase theorem statements. To solve the identified inconsistencies, the paper presents a successful attempt to neutralize them using additional criterial conditions.

The assumptions proposed by the paper's author have found their complete scientific rationale, making a consistent concept. The paper is well organized in its layout. This enables us to trace the development of strictly interconnected ideas, i.e. from a review of known theorem interpretations and its wording clarification to the terms to make a classification of externalities updated by the author. The mentioned reasoning and conclusions from the paper allow us to move away from methodological stereotypes dominant in academic minds and take another view of a true wording for the Coase theorem.

To sum up, we may conclude that a group of the proposed hypotheses, supported with a wide overview of academic literature, is meaningfully productive for the development of the institutionalism theory.

Weaknesses

The chosen research direction is not a poorly explored field of science, there have been many publications on this issue. Besides, some researchers deny the Coase theorem's influence and this let us only say of the findings presented in the paper as of an alternative point of view.
